THE ATA COMPLETED THE PUBLICATION "YOUR COMPLETE GUIDE TO THE ARIZONA NATIONAL SCENIC TRAIL" AND ADDED PASSAGES PROFILES, UPGRADED PASSAGE MAPS, AND EXPANDED TRAIL INFORMATION AVAILABILITY ON THE ATA WEBSITE. MEMBERSHIP INCREASED BY 10%, 4 NEW REGIONAL STEWARDS WERE APPOINTED IN 2013, AND NEW FINANCIAL ASSISTANCE WAS SECURED FROM BLM TO SUPPORT SEEDS OF STEWARDSHIP AND TRAIL OPERATIONS.
